Student Parliament of the Academy of Vocational Studies (hereinafter: Academy) is the organ through which the students of colleges that are members of the Academy of vocational studies exercise their rights and protect their interests at the Academy.

Student Parliament consists of 3 representatives from each vocational college that is within the Academy.

Student Parliament has in its current session 24 members.

The term of office for the members of the Student Parliament of the Academy is one year.

The President, Vice president and Vice-rector form the Presidency of the Student Parliament.

Student Parliament of the Academy:

- 1. elects and dismisses the president and the vice-president of the Student Parlament;
- 2. issues general acts on its work;
- 3. forms working bodies that perform specific tasks and duties of the Student Parliament;
- 4. elects and dismisses student representatives in the organs and bodies;
- 5. brings the annual plan and programme of the activities of the Student Parliament;
- 6. brings the general act which defines the organizational and functional connection between the Student Parliament of the Academy and the student parliaments of the vocational colleges within the Academy;
- 7. considers issues and conducts the activities related to assurance and evaluation of the quality of teaching, reform of the study programmes, analysis of the efficiency of studying, determining the number of ECTS credits, improvement of student mobility, encouraging of research and scientific work of students, protection of students' rights and improvement of student standards;
- 8. takes care together with the President of the Academy, the Council of the Academy and the Senate of the Academy of the activities of the Center for Student Organization, the Center for Career Development and the Center for Information in accordance with the general act that is adopted by the Council;
- 9. organizes and conducts the programme of extra-curricular activities for students;
- 10. participates in the procedure for self-evaluation of the Academy of vocational studies in accordance with the general act adopted by the Senate;
- 11. realizes cooperation among students of the colleges of vocational studies as well as international cooperation;
- 12. elects and dismisses members of the Student Conference of the Academy of Vocational Studies, from among the students who are members of the Student Parliament of the Academy;
- 13. elects and dismisses student representatives in the organs and bodies of the Academy: that is 3 representatives in the Academy Council and 3 representatives in the Academy Senate from among the members of the Student Parliament of the Academy;

- 14. elects and dismisses student representatives in other institutions and associations in which there are student representatives of the Academy in accordance with the general act of the institution, association, that is the Academy;
- 15. gives proposals to the Senate for determining the annual plan of activities of the Academy;
- 16. adopts the annual report on the work of the student vice-rector;
- 17. adopts the finacial plan and the report on financial operations of the Student Parliament of the Academy;
- 18. adopts the annual report submitted by the President of the Student Parliament of the Academy;
- 19. performs other acitivities in line with the Law, the Statute and the general acts of the Academy.

Activities of the Student Parliament and the process of decision making are more closely defined by the Statute of the Academy and the Rules of Procedure.
