Pursuant to the Article 56 of the Law on Higher Education (*The Official Gazette of the Republic of Serbia* N° 76/05, 100/07, 97/08, 44/10, 93/12, 89/13 and 99/14) the Network of vocational colleges termed "The First Academy of Vocational Studies" (hereinafter the FAVS) on April 28th, 2015 established

THE STUDENT PARLIAMENT OF THE FIRST ACADEMY OF VOCATIONAL STUDIES

Article 1.

The Student Parliament of the First Academy of Vocational Studies

The Student Parliament of the First Academy of Vocational Studies (hereinafter the FAVS) is a body through which students of the vocational colleges-members of the FAVS exercise their rights and protect their interests within the FAVS

Article 2.

The Student Parliament of the FAVS is composed of three representatives from each vocational college within the FAVS

The Student Parliament currently comprises 24 members.

The Mandate of the members of the Student Parliament of the FAVS last for one year.

The President and two vice presidents comprise the Presidency of The Student Parliament of the FAVS.

Article 3.

The Student Parliament of the FAVS

- 1. elects and dismisses the president and vice presidents of the Student Parliament
- 2. adopts general acts which regulate its work
- 3. forms working bodies which deal with specified activities which are not in the jurisdiction of the Student Parliament
- 4. elects and dismisses the representatives of students in various bodies and boards
- 5. adopts the Annual Plan and Programme of the activities of the Student Parliament
- 6. adopts general acts which regulate the organisational and functional connection between the Student Parliament of the FAVS and individual Student Parliaments of the vocational colleges –members of the FAVS
- 7. considers issues and conducts activities regarding quality assurance and management, study programmes reforms, the analysis of the efficiency of studying, the ECTS credits adoption, improvement of student mobility, scientific research of students, protection of students' rights and improvement of student standard.
- 8. along with the Board of Directors of the FAVS, the Council and the Senate, the Parliament deals with the activities of the Centre for Student Organisation, Centre for Career Development and Info Centre, in accordance with the General act adopted by the Council
- 9. organises and conducts the programmes of extracurricular activities
- 10. implements student co-operation between the vocational colleges, as well as international co-operation

- 11. elects and dismisses the representatives of the Student Conference of the Academy of Vocational Studies from among the members of the Student Parliament
- 12. elects and dismisses the representatives of students from among the members of the Student Parliament for the boards and bodies of the FAVS: 3 representatives for the Council, 3 representatives for the Senate
- 13. elects and dismisses the representatives of students in other institutions and associations in which there are representatives of students of the FAVS, in accordance with the General Act of the institution, association i.e. the FAVS
- 14. gives recommendation to the Senate regarding the proposal of the Annual Activity Programme of the FAVS
- 15. adopts the annual report on the work of the student vice rector
- 16. adopts financial plan and report on financial activities of the Student Parliament of the FAVS
- 17. adopts the annual work report submitted by the president of the Student Parliament of the FAVS
- 18. performs other activities in accordance with the Law, the Statute and general acts of the FAVS

Article 4.

The activities of the Student Parliament and the manner of making decisions are regulated in more detail by the Regulations on the Activities of the Student Parliament of the FAVS.
